

IN OHIO, THE TEACHERS AND FIRST RESPONDERS BACK TO WORK ACT WILL PROVIDE \$1.1 BILLION IN FUNDS TO SUPPORT UP TO 14,200 EDUCATOR JOBS

The Teachers and First Responders Back to Work Act will save or create nearly 400,000 education jobs through critical investments in the education of our nation's children. Specifically, The Teachers and First Responders Back to Work Act will invest \$30 billion to support state and local efforts to retain, rehire, and hire early childhood, elementary, and secondary educators. Facing a \$3 billion projected budget shortfall in 2013, cuts to state and local spending on education will place thousands of Ohio teacher jobs at risk. The Teachers and First Responders Back to Work Act will provide Ohio with an additional \$1.1 billion in funds that will support 14,200 education jobs, provide a jolt to the state economy, and improve the quality of education. By asking millionaires to pay their fair share, The Teachers and First Responders Back to Work Act will grow the Ohio economy without adding a dime to the deficit.

Ohio Budget Shortfall Forced State To Slash Education Spending by 2.2 Percent. As a result of the most severe fiscal crisis since the Great Depression, Ohio faced a budget shortfall of \$3 billion in 2012, a staggering 11.1% of the state's General Fund. Given the dramatic reduction in state revenue, the state was forced to slash funding for educational programs and services. In Ohio, elementary and high schools are currently receiving 2.2% less state funding this year than in 2008. In Ohio, 4,300 Education Jobs Have Been Lost Since 2008. Given Ohio's cuts to education programs, local school districts are forced to cut back on educational programs and services, often laying-off needed teachers and other critical staff, or raising additional revenue to cover the shortfall. As a result, Ohio schools have cut 4,300 education jobs since 2008. These unprecedented layoffs extended the recession and have slowed the recovery in Ohio. Democrats Helped Ohio Avoid an Even Worse Situation, Preventing Thousands of Potential Layoffs. Without Democratic intervention in 2010, Ohio school districts would have been forced to lay off as many as 1,200 teachers. Recognizing the financial difficulty that many state and local governments were experiencing, Democrats shepherded the bipartisan Education Jobs Act into law, thereby protecting 5,500 education jobs in Ohio.
