



IN SOUTH CAROLINA, THE TEACHERS AND FIRST RESPONDERS BACK TO WORK ACT WILL PROVIDE \$429.5 MILLION IN FUNDS TO SUPPORT UP TO 6,400 EDUCATOR JOBS

The Teachers and First Responders Back to Work Act will save or create nearly 400,000 education jobs through critical investments in the education of our nation's children. Specifically, The Teachers and First Responders Back to Work Act will invest \$30 billion to support state and local efforts to retain, rehire, and hire early childhood, elementary, and secondary educators. Facing a projected budget shortfall in 2013, cuts to state and local spending on education will place thousands of South Carolina teacher jobs at risk. The Teachers and First Responders Back to Work Act will provide South Carolina with an additional \$429.5 million in funds that will support 6,400 education jobs, provide a jolt to the state economy, and improve the quality of education. By asking millionaires to pay their fair share, The Teachers and First Responders Back to Work Act will grow the South Carolina economy without adding a dime to the deficit.

South Carolina Budget Shortfall Forced State To Slash Education Spending by 24.1 Percent.

As a result of the most severe fiscal crisis since the Great Depression, South Carolina faced a budget shortfall of \$630 million in 2012, a staggering 11.5% of the state's General Fund. Given the dramatic reduction in state revenue, the state was forced to slash funding for educational programs and services. In South Carolina, elementary and high schools are currently receiving 24.1% less state funding this year than in 2008. In South Carolina, 8,400 Education Jobs Have Been Lost Since 2008. Given South Carolina's cuts to education programs, local school districts are forced to cut back on educational programs and services, often laying-off needed teachers and other critical staff, or raising additional revenue to cover the shortfall. As a result, South Carolina schools have cut 8,400 education jobs since 2008. These unprecedented layoffs extended the recession and have slowed the recovery in South Carolina. Democrats Helped South Carolina Avoid an Even Worse Situation. Preventing Thousands of Potential Layoffs.

Without Democratic intervention in 2010, South Carolina school districts would have been forced to lay off as many as 4,000 teachers. Recognizing the financial difficulty that many state and local governments were experiencing, Democrats shepherded the bipartisan Education Jobs Act into law, thereby protecting 2,600 education jobs in South Carolina.
